i. Spring League U16 Girls

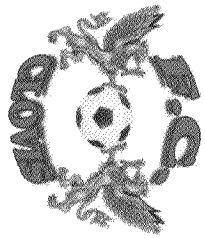
- FC Clovis holding there own against a 1st Team from COSC
